1.	Amendment of the Act of Assam Rajiv Gandhi University of Cooperative Management (ARGUCOM): Matter is placed in the EC for discussion and approval.	1/33.	EC has approved the draft amendment bill of the Act of the University with few changes in the draft bill which is mentioned below: 1. In the Clause (zg) of Section no. 3 and Clause (1) of Section no. 4 and in the Section no. 70 (which are detailed in Annexure 1 of the draft bill), EC has advised the following justification for the change of nomenclature of Assam Rajiv Gandhi University of Cooperative Management (ARGUCOM) to “Rongpur

University of Management”.

Justification 1: Since the University is situated in the historic capital city of the Ahom Kingdom, i.e., Rongpur (the current name is Sivasagar), the name: “Rongpur University of Management” itself will carry the rich heritage of Assam. Moreover, the approved architectural plan of the University also reflects the historic monuments of the Rongpur city, i.e., Rongghar (library, auditorium, health centre, canteen etc.), Kareng Ghar (Academic building, administrative block), Talatal Ghar (Boy’s and Girl’s hostel, faculty quarter), Golaghar (Staff quarter), Ghanashyam temple (gate), two ponds (sagar), four Duwars (Pub, Pashim, Uttar and Dakshin) and three Khawoi.

Justification 2: Keeping in view of the domain & vision of the University, the term “Cooperative Management” appears to be unduly restrictive. This has led to the reluctance of the students and parents to explore the academic studies offered by the University. Therefore, in order to properly reflect the vision, scope & expectations of the activities of the University, it is proposed that the University be better called as the “Rongpur University of Management”.

Justification 3: The name change of the University is also required because: the administrative control of the University has been shifted from Cooperation Department to Higher Education Department, Govt. of Assam as per notification vide no. COOP.192/2021/5 dated 29/07/2021.

- 2. In the Clause (3) of Section no. 12, EC has advised the retirement age of the Vice Chancellor on attaining 70 years from the present 65 years.

Justification: Some of the State University’s Act has already been passed and the age of the Vice
