4	Budget Approval of the University	3/2	The Budget for the FY 2022-23 was placed before the Court and the same was approved. The Members suggested taking necessary steps to draw the amount from the Govt. of Assam as early as possible. The Court also suggested to take initiative to receive Administrative Approval and Financial Sanction of Rs. 50 crores from Govt of Assam for construction of one Academic Building, one Boys Hostel, one Girls Hostel and one Warden Quarter for which the DPR had already been submitted.

The court of the University discussed about the proposed amendments of the Act of the University made in pursuance of the transfer of administrative control from Cooperation Department to Higher Education Department and approved the same without modification. 2. The Court appreciated the 4 completed innovations made by the students of ARGUCOM and 12 ongoing innovation projects and suggested for patent application for all innovation projects. 3. The Court also suggested for tie up with BIRD(NABARD), Lucknow for accreditation of upcoming training programmes.
